- The labeling of form fields is not always clearly associated with their description (WCAG Criterion 1.3.1),
- User registration for visually impaired users is not possible directly through the customer section – registration occurs only during the ordering process. (WCAG Criterion 3.3.3 – Error Suggestion)
- Videos do not include subtitles (WCAG Criterion 1.2.2).

We are working on resolving these shortcomings in the upcoming website updates.
